Be advised, MPPDC under National Fish and Wildlife Foundation (NFWF) Grant Agreement ID #0318.19.066887 and NFWF Proposal ID 66887 titled *Creating Coastal Resiliency through Living Shoreline Strategies (VA)* has determined as per VPPA **2.2-4303 2E** that Sole Source is the only practicable way to handle project construction at 292 Riverview Road, Port Haywood / Mathews 23138 for Tax Map 35-A-44 and 35-A-40.
